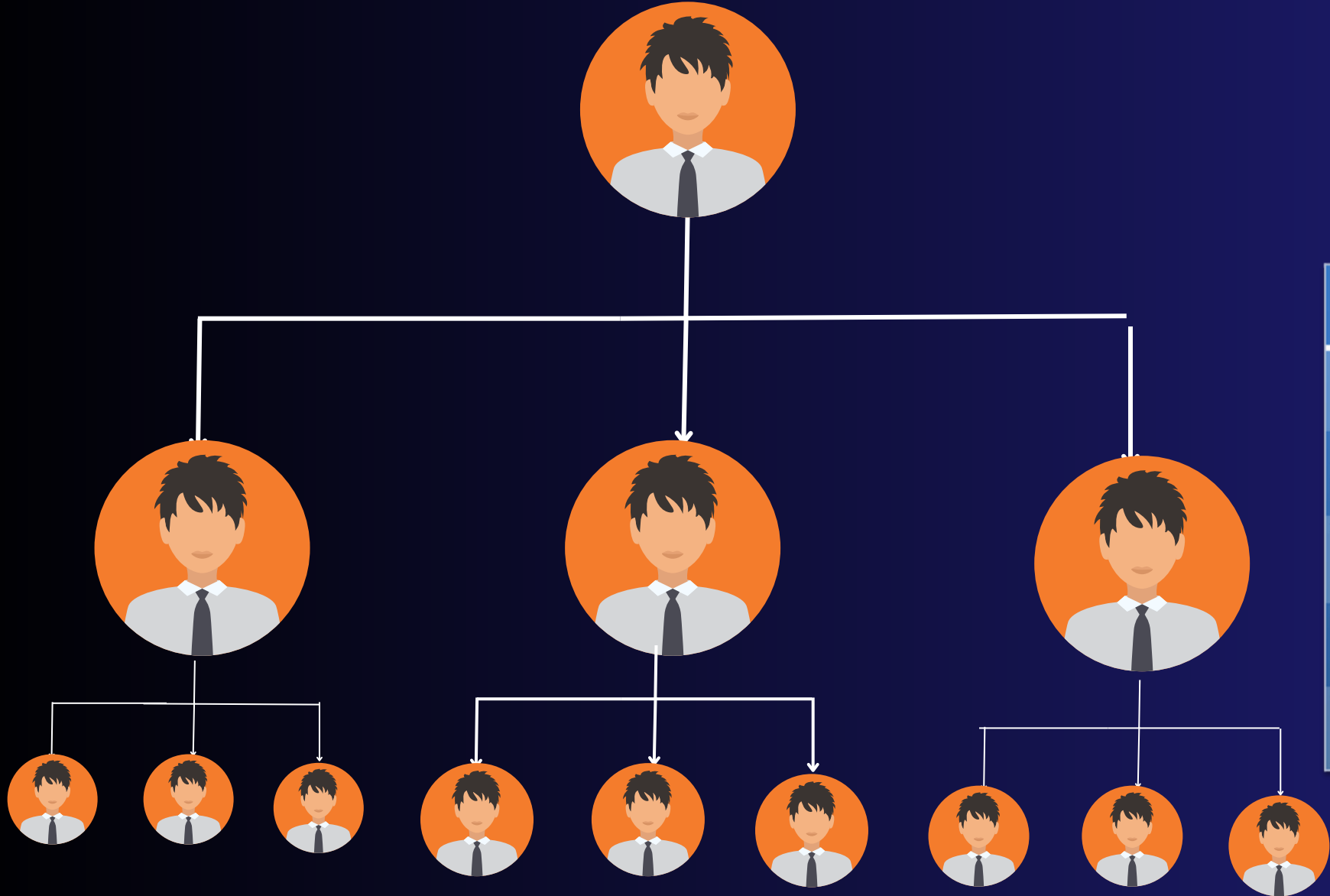


CTO Company turnover income
